IV. Special On-line Learning Schedule Change

A. Special On-line Learning Schedule Change

Special on-line learning change- 6:26pm

Dan Davis went over the special on-line learning schedule change proposal and said we may or may not vote on it tonight. Gave thoughts on school being the safest place. He talked to 2 superintendents and both have considered, but have decided not to do virtual after breaks. They are waiting to see if any symptoms occur after being around family. Mike also shared a similar view based on data and conversations he has had. Each Governance Council member expressed their thoughts and the discussion went back and forth on their views with going virtual after breaks. Right now we just don't know what will happen after breaks. Some expressed the concern of once we go virtual we'll have a hard time going back. Another idea was waiting to see how Thanksgiving goes and then deciding on after the New Year. Also, we may have better control having the students in our environment at school. Other Governance Council members expressed concerns that the data shows Covid is just going to keep getting worse. For some, there has been a direct impact on their family. No conclusion was made during this discussion. The Governance Council members wanted to hear from the parents and teachers as well before making a decision. It was concluded that we don't have enough data to make a decision tonight. A survey will be sent out to parents and teachers to get more information.

V. Public Comment

A. Public Comment

Public comment- 7:03pm

Several parents expressed their opinion on whether or not ROLES should go virtual after holiday breaks. Dan has received several emails in support of staying in person and others wanting to go virtual from parents present at the Governance Council meeting and those who are not in attendance. Parents have opposing views on the topic with no clear consensus on what ROLES should do. Parents would like to know how the teachers feel. Parents also discussed how teachers cannot provide perfect virtual and in person instruction. There are not enough resources. One parent is wondering if we have looked at the sick to in person ration to decide if/when to go virtual? Parents are concerned families are not going to stick to their bubble over break and therefore could be coming back to school symptomatic after breaks. Many parents have asked for the Governance Council to consider the proposal.
