- B. Cindy had inquired about how many sections we could offer
 - 1. Nick: We can offer a 4k and expand our Charter school
 - We CAN offer two sections, but then only one section in the next grade. It would cause problems
 - 3. We could offer the 4k as a separate school. Parents would have to lottery into 4k and then lottery again if they desire to get into our 5K.
 - 4. We would have to have an authorizer
 - Can expand our current school, and change the contract because we're adding another grade level
 - a) Could then apply for an expansion grant financially makes sense
 - 6. Could decide to have a second school that we govern
 - a) Would need a contract for that
 - b) Would apply for planning with implementation or just implementation grant
 - If we are going to be offering multiple sections and then reduce, then we'll want to have that discussion at DPI
 - a) Or just expand and have one section of 4K
 - Between now and August, Cindy will do some more research to better understand our needs and present her findings in August
