    - 1. Korinne and Adam have been working to address as many as the feedback items that came from the parent forum
    - 2. Facilities rent agreement with Riveredge is still being negotiated
      - a) Document does not address all of the concerns we had raised
      - b) ROLES currently pays a rate of \$7.00/student/day to use the classrooms that we have. There is an additional \$5000 fee to gain access to pay for educational and adventure programming. Riveredge has suggested that they would like to raise the rate to \$8.00/student/day. We had proposed a \$7.25/student/day rate, but it was denied by Riveredge stating that they are raising all of their fees across the board. They agreed to change the rate to match our enrollment numbers more frequently based on actual

daily enrollment instead of the State 2nd Friday count days, and to bill us monthly instead of semi-annually. We have guaranteed that we will pay 75% of the total fees we paid to Riveredge last year this next year. Fortunately our enrollment numbers are shaping up to support that commitment.

- c) There are two pieces of property that are contenders for the next iteration of the school. Both properties are within 5 minutes of Riveredge.
  - (1) 1 is ~60 acres that we could purchase outright.
  - (2) 1 is ~35 acres (a lease), but is bordered by park lands that we could potentially use and explore.
  - (3) In both cases, we could potentially need a temporary solution due to lack of infrastructure (running water, bathrooms, internet) due to negotiations between all parties.
